Voraussetzungen	• Application • General requirements for admission to the profession of lawyer • Officially certified copy of the examination certificate on the acquisition of the qualification for judicial office according to the German Judges Act or • No grounds for refusal of admission • Activity in accordance with Section 46 (2) to (5) of the Federal Lawyers' Act (BRAO) • Receipt of the administrative fee • Swearing in
Kosten	Fees are charged in accordance with § 192 of the Federal Lawyers' Act (BRAO) in conjunction with the Fee Statutes of the Hanseatic Bar Association Bremen.
Verfahrensablauf	Please contact the Hanseatic Bar Association Bremen with your request for admission as an in-house lawyer. You can find the relevant application forms either here and/or on the website. These must be completed, signed and sent to the bar association with the required documents.

Modul	Sachverhalt
	If you have a corresponding post office box, you can submit the application via a citizen's post office box connected to the EGVP infrastructure. The way of e-mail and postal transmission is also open to you. You can submit original documents in person or by mail. These will be returned after processing.
Bearbeitungsdauer	The processing time depends on the specific activity for which admission is requested and the completeness of the documents submitted. In addition, there is a dependency on the processing time of the Deutsche Rentenversicherung Bund, which is involved in the admission procedure.
Frist	It is pointed out that the application for admission as an in-house lawyer does not replace the application for exemption from the statutory pension insurance obligation at the Federal Pension Insurance. The application for admission to the Bar Association also has no effect in this context in terms of meeting the deadline.
