Volltext	Do you want to run your law firm in a company under German law, a European company or a company under the law of a member state of the EU or a contracting state of the European Economic Area pursuant to Section 59b (2) sentence 1 BRAO? In principle, the practice of law requires admission to the Hanseatic Bar Association in Bremen pursuant to Section 59f (1) BRAO. No admission is required for partnerships in which there is no limitation of liability of natural persons and to which only lawyers or members of one of the professions mentioned in Section 59c (1) sentence 1 no. 1 belong as partners and as members of the management and supervisory bodies. A voluntary application for admission may be filed.

Voraussetzungen	The professional practice company, its shareholders and the members of the management and supervisory bodies must meet the requirements of Sections 59b, 59c, 59d (5), 59i, 59j BRAO.
Kosten	For the admission of the professional practice company, fees are charged according to the respective fee schedule of the Hanseatic Bar Association Bremen. You will find the link to the fee schedule under "Further Information" - Where can I find out more?" - Fee schedule of the Hanseatic Bar Association Bremen".
Verfahrensablauf	The application form is available on the website of the Hanseatic Bar Association Bremen. You will find the link there under "Further information"- Where can I find out more? - "Forms/ Application for Admission of the Hanseatic Bar Association Bremen". Submit the completed application with all required documents via the beA or in writing to the Hanseatic Bar Association Bremen and transfer the applicable fees.

Frist	The approval must be obtained before the professional practice company starts its business activities.
