We can discuss this together at the consultation appointment. The individual counseling and testing services include: Syphilis, Chlamydia, Gonorrhea, Hepatitis B, Monkeypox (Mpox).</p> <p>There is a possibility of vaccination against hepatitis A+B and monkeypox.</p>                 |
