Teaser	Do you want to transfer the permit for your cab business to another entrepreneur? You must submit an application to do this.
Volltext	You need a permit to transfer the authorization to transport passengers commercially by cab. You can submit a corresponding application to the relevant transport authority.
Erforderliche Unterlagen	• Informal justification as to why the cab permit should be transferred • Declaration of the licensee's consent to assume the obligations arising from the cab permit • Clearance certificates from the tax office, the employers' liability insurance association and the social security authorities
Voraussetzungen	• The applicant is already in possession of a cab permit as an entrepreneur. • The safety and efficiency of the business are guaranteed. • There is no evidence that the applicant is unreliable as an entrepreneur or that the person appointed to manage the business is unreliable.
Kosten	The transfer is free of charge for the transferring party.
Verfahrensablauf	Proceed as follows to obtain a transfer of the permit for the commercial transportation of passengers by cab: • Submit a corresponding application to the transport authority responsible for you and enclose all the necessary documents with the application. • The authority will process your application and carry out the necessary hearing procedures.

Modul	Sachverhalt
	You will receive a decision on the transfer of the cab permit. If applicable, you will receive the certificate of approval.
Bearbeitungsdauer	The processing time may depend, among other things, on whether all documents relevant to the decision have been submitted or whether additional requests for documents become necessary.
Frist	Deadlines only start to run when an application is ready for a decision. If your application is complete, a decision will be made within 3 months. The deadline can be extended by 3 months if necessary.
